iii.) Motion – Civic Numbers

WHEREAS the General Regulation under the Emergency 9-1-1 Service Act requires that an address be assigned to all residences and businesses in New Brunswick and that it be posted;

WHEREAS as a result of local governance reform, many areas of New Brunswick now belong to newly restructured local government entities;

WHEREAS the Executive Directors of the local governments in Kent County recommend that this service be provided by the KRSC;

THEREFORE, BE IT RESOLVED THAT the Kent Regional Services Commission be responsible for providing civic numbers to all properties located in the local governments of Kent County.

# iv.) Motion - Appointment of By-Law Enforcement Officer

### 23-84

WHEREAS in accordance with Section 72 of the *Local Governance Act, SNB 2017, c 18*, Council may appoint By-Law Enforcement Officers for the Local Government and determine their mandates;

BE IT RESOLVED that the following persons be individually appointed as a By-Law Enforcement Officer for the Local Government:

- Mya LIDSTONE
- Sylvie MILLS

BE IT FURTHER RESOLVED THAT the By-Law Enforcement Officer (officer) is employed for the preservation and maintenance of public peace;

AND THAT the duties, powers, authorities and immunities of the Officer are as follows:

- a) The Officer has the powers as defined by Section 14(3) of the *Police Act, SNB 1977,* c P-9.2.
- b) The Officer is appointed as a Park Ranger in accordance with By-Law 21-04 of the Town of Richibucto.
- c) The Officer has the duty to enforce By-Law 21-04 of the Town of Richibucto.
- d) The Officer has the lawful authority to investigate violations, perform inspections, enter lands, buildings and other structures, issue tickets, lay information, serve documents, issue demands, orders and perform all other duties and tasks, in accordance with all the applicable Sections and Regulations of the *Local Governance Act, SNB 2017, C 18* and as established by By-Law.
- e) The Officer is authorized to exercise discretion in the course of their duties.
- f) The Officer is an officer acting under the law and is protected in accordance with the *Protection of Persons Acting Under Statues Act, RSNB 2011, C 210.*

BE IT FURTHER RESOLVED THAT the above-mentioned appointments continue as long as the Officer is employed or retained by the Local Government.

# v.) Decision notice – zoning confirmation fees
